## Information Collection, Use and Disclosure

DataFarming may collect, use or disclose personal information about you for the following purposes:

- Providing you with the goods or services requested.
- To modify or improve the goods or services provided to you.
- Customer support.
- To manage the contractual relationship between you and DataFarming.
- Client and business relationship management.
- To perform audits, security and fraud monitoring and prevention.
- To process transactions.
- To ask for ratings and reviews of the products and services we offer.
- Marketing of products and services to you.
- To administer the employer/employee or principal/contractor relationship.
- To comply with legal process or to protect DataFarming's interests.

The types of personal information we may collect, use or disclose about you includes but is not limited to:

- Organisations involved in the payments systems including financial institutions, merchants and payment organisations.

Whenever it is reasonable or practicable to do so, we will collect your personal information directly from you. Sometimes it will be necessary for us to collect information from a third party or a publicly available source.

We may disclose your personal information to recipients within Australia or to overseas recipients including but not limited to recipients in the Philippines. Should information be required to be sent overseas, we will take steps to protect the privacy of your information.
